2. Enter your user name and password and select login.

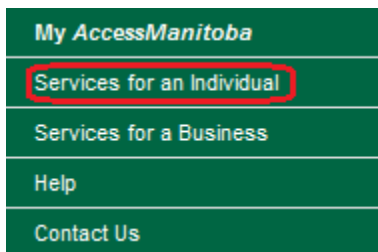
